



Kindly refer the online RTI application dated 20.02.2017 (Reg. No. MOOCD/R/2017/50016) sought by Shri Nirmal Kumar Bhagat, Ghaziabad, transferred by MoES, New Delhi to ICMAM Project Directorate under section 6(3) of RTI Act, 2005.

2. The information sought by the applicant is as under:

1.	It is a fact that through an OM dated 29 th June 2016, Ministry of Earth Sciences after approval of department of expenditure, Ministry of Finance has prohibited use of staff car for commuting MFCS (In situ) promoted Scientist G for commuting between office and residence.	Ans: Only one Scientist G is available in ICMAM-PD. The Scientist G, who is the Head of ICMAM Project Directorate is not availing staff car facility for commuting between residence and office.
2.	Whether the said OM also prohibits grant of Transport Allowance of INR 7000 plus DA to such MFCS (In situ) Scientist G	
3.	The list of such MFCS promoted Scientist G in Ministry of Earth Sciences, in its attached and subordinate offices and autonomous institutions which are still continuing to be provided staff car for commuting between office and residence	
4.	The amount of Transport allowance being paid to each of the Scientist G in Ministry of Earth Sciences, its attached and Subordinate offices and autonomous institutions, who are not availing staff car for commuting between residence and office
